The co-Chairs thanked the outgoing members of the Management Committee and welcomed new management committee members.

At the end of formal AGM business, the meeting closed at 19.29pm.

Discussion:

Cllr Baldwin offered to help with facilitating communications and accessing the groups that it has been suggested Forum should engage with, following the forthcoming meeting with RBWM. He was thanked by MNF Committee for his support.

Richard Davenport offered to put newly elected treasurer, Phil Adkins, in touch with Waterways Treasurer, as they will be the accountable body to handle the forthcoming grant and MNF finances. Friends of Maidenhead Waterways were thanked for their support.

Concern was expressed in the Q+A session that the Forum has not been meeting as a wider group of members on zoom. The co-Chairs explained that part of the reason is that until we find a way to agree an area with RBWM there has been little to discuss with all forum members. It is hoped that with the resumption of discussions with RBWM there will be sufficient material to discuss at a Forum meeting which will be hybrid, real life plus Zoom. Joint Chairs Ian Rose and Andrew Ingram agreed to look into finding a way to make this work and find a suitable location.

The next Management committee meeting is due to be held on 20th July. Details to follow.
