## Summary

Maidenhead Neighbourhood Forum is an unincorporated body established to create a Neighbourhood Plan for the seven unparished wards of Maidenhead.

Funding in 2021-2022 was from a central government grant administered by its agent, Groundwork UK on behalf of Locality. A requirement of the grant was that all unused funding was to be returned to Groundwork UK at the end of the financial year (31st March 2022). This has been done.

NatWest credited the bank account with £50 as a gesture of goodwill in 2019 for an error when the account was set up, that had no financial impact. That £50 is the current balance in the account.

These accounts are prepared on a cash basis.

### Grant

The Locality grant received from Groundwork UK was £1,054.00.

## Actual spend

In total, £683.99 was spent. This was for the MNF website (£12.33), provision of computer support (£135.00), computer software (£363.98), zoom fees (£172.68).

## Repayment

Unspent grant of £370.01 was repaid to Groundwork UK on 3rd April 2022. They have acknowledged receipt and confirmed that MNF's financial obligations for 2021-2022 have been fulfilled.
